AUSTRALIA

Welcoming Australia was Welcoming International's first Founding Member. Their Welcoming Cities initiative, supported by the Scanlon Foundation, works on shifting attitudes towards newcomers by supporting regional communities to better identify and understand the process of welcoming people to their communities. Welcoming Cities supports local councils and community leaders through a network built around knowledge sharing, multi-sector partnership facilitation, celebrating success, and a national Welcoming Standard that outlines the policies and practices needed for diversity and inclusion. Throughout their work, they acknowledge the vital role of Aboriginal and Torres Strait Islander communities in welcoming activities, as the First People on Australian soil, and the continuation of their cultural, spiritual, and ceremonial practices, is deeply embedded within Welcoming Cities' culture. The initiative is growing rapidly, working with 50 councils as of mid-2020 and the number of involved cities and councils expected to double within the next year.

GERMANY

Bertelsmann Foundation and PHINEO launched the Weltoffenen Kommunen initiative to ensure that newcomers and long-term residents (including those with migrant backgrounds), feel welcome in Germany. The initiative supports cities and communities across Germany through a self-check tool, support to municipal decision makers, and facilitation of community dialogue to shape local responses and develop inclusive narratives. The self-check tool, inspired by Welcoming Standards from around the world, helps municipalities analyze their current work and further develop their integration practices. In 2020 the project received funding from the German government to support 40 new cities and communities in their welcoming efforts.

NEW ZEALAND

Since 2017 we have worked with Immigration New Zealand to devise and support its pilot Welcoming Communities program across 10 councils. In 2018, Welcoming Communities became a Founding Member of Welcoming International and created the New Zealand Welcoming Communities Standard, which now informs a comprehensive accreditation system through which a community's inclusion efforts can be awarded formal recognition. New Zealand, which was the first national government to launch a welcoming program, continues to inspire the welcoming ecosystem as it works towards growing the program to more of New Zealand's councils.

UNITED KINGDOM

Inclusive Cities is a knowledge exchange program led by the Global Exchange on Migration and Diversity at the University of Oxford. It supports cities in the United Kingdom to facilitate the welcoming, and subsequent integration and inclusion, of newcomers. The program provides the intersection between academic research, peer learning between local cities, and international learning via partnership with Welcoming International.

The first phase of the Inclusive Cities program started with six cities, and as of mid-2020 it includes a total of 12 cities making progress to ensure that the U.K. is welcoming to all. Guiding that process is the Inclusive Cities Framework, which sets out a framework of core principles and priority areas which all municipalities can work towards in becoming inclusive cities.
